#### **ALARM AND DISPATCH SERVICE**

### **CHATHAM ALARM PERMIT**

All alarm systems must be registered with the Alarm Coordinator within five (5) business days of installation or takeover. No refund of a registration or renewal fee will be made.

The registration fee is \$36.00 for monitored and non-monitored residential and business alarm systems. There is NO charge for applicants aged 65 plus. The fee covers a three (3) year period beginning the month of registration and includes two (2) non-chargeable false alarms during each twelve-month period.

An alarm registration may not be transferred to another person. An alarm registration may be transferred to another alarm site; however, the records pertaining to any false alarms during that time period will also transfer with the registrant.

### **False Alarm Policy**

Number of Alarms

Police response depending on the number of false alarms emitted from an alarm system within each one (1) year period from the date of registration or renewal based upon the following schedule:

Number of Alarms	100
1 <sup>st</sup>	\$0.00
2 <sup>nd</sup>	\$0.00
3 <sup>rd</sup>	\$100.00
4 <sup>th</sup>	\$100 plus (Suspension of Police response for 1 year)

An alarm user whose alarm system causes a request for police response to a false alarm to a non-registered alarm site (whether suspended or never acquired) will be subject to an administrative fee of \$200.00, in addition to any other administrative fees.



# **Suspension of Police Response**

Police response will be suspended to alarm dispatch requests if it is determined that:

- The alarm user has four (4) or more false alarms in a one (1) year period; or
- There is a false statement of material fact in the application for registration; or
- The alarm user has failed to make timely payment of a fee assessed pursuant to the provisions of this bylaw.

# **PROTECTION PLUS POLICIES**

The Chatham Police is responsible for all registrations and fees for police response to alarm holders. All false alarms are billed directly by the Chatham police department.

Customers who do not wish to register with the Police, we offer an alternative service for Guard response.

**PROTECTION PLUS offers a Private Guard Response in Chatham.** This service provides a response from a Private Guard company that will dispatch qualified Guards to your residence. Should the dispatch be the result of a false alarm, the Guard will leave a Patrol Report at your house. However, should the emergency be real, the Guard will immediately contact the Police and request appropriate action.

All **Panic Button Signals** will still be attended to by the Police (and are subject to fees if deemed false).

**Residential** \$4.95 + tax monthly or \$80.00 + tax per response **Commercial** \$7.95 + tax monthly or \$95.00 + tax per response

<u>Note:</u> To reduce false alarms responses, please remember to call the monitoring station on all alarms. Please do not wait for their call.
